1. The Contractor/Agency shall undertake Pest control measures through herbal treatment using high standard herbal non-toxic chemicals/ insecticides of Government approved brands only. Contractor should ensure that the dead rodent should be cleared from the premises of the Resorts.
2. The Contractor/Agency should obtain every prior information to risks contingencies and other circumstances in their own interest and shall be deemed to have full knowledge to carry out their most effective service to the ultimate satisfaction of the Management during any part of the contractual period.
3. Non-toxic herbal paste/ gel shall be used which is not harmful to human being and not risky.
4. The Contractor/Agency shall entirely responsible to maintain separate records duly signed by the concerned Resort in- Charge/ Housekeeping Supervisor apart from their challans every month clearly indicating minimum frequency of operation.
5. The payment shall be made in four equally divided installments on quarterly basis on the production of certified bills from the concerned Resort in-charge/Housekeeping Supervisor.
6. The Competent Authority also reserves the right to place initial work order on trial basis and shall have full right to terminate the services with immediate effect during any part of the contractual period without assigning any reason, which will be binding on the successful contractor.
7. Penalty Clause, deduction of 5 % from the bills will be deducted if services are found unsatisfactory on quarterly basis.
8. The area of Pest and rodents Control services to be done are mentioned in Annexure - II of ATC document.
9. The specification of pesticides shall have to be an appropriate oil based/Gel based / baygone/any suitable harmful free formulation to be exclusively used in the Resorts as per our requirement and also Rodent control treatment so that rats can be controlled.
10. Pesticide compounds, formulations, and application methods that present the lowest potential hazard to humans and the environment to be used. Non-pesticide technologies such as trapping and monitoring devices for rodents control can also be used.
11. Rate to be quoted considering the total areas on Yearly Contract basis.
12. The Contractor/Agency must have a commercial pest control license issued by the A & N Administration and the same is to be furnished while submitting the bid.
13. The Contractor/Agency must have EPF registration and Certificates to be enclosed during submission of bid.
14. The Contractor/agency shall be responsible for pest Control Treatment as per the directions to be received from the respective Resort in-charge from time to time.
15. The area for Pest Management Service is for reference and the payment shall be made as per the actual area.
16. The Contractor/ Agency shall submit/upload bills for Hornbill Nest Resorts.
17. Delivery Address - As per Annexure- II
18. The Pest Management Service Provide for Hornbill Nest Resort, Sri Vijaya Puram.
