2. **OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. **Generic**

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, within 5 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modification required in the drawings within 5 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing– the delivery period shall be refixed without LD for the period of delay in approval of Drawing.

## 3. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

#### 10. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Bidders are required to deposit EMD in the form of FDR payable at Nagar Nigam, Saharanpur in favour of Municipal Commissioner, Nagar Nigam, Saharanpur. Bidder must upload scanned copy/proof of FDR along with the bid and ensure delivery of hard copy to the buyer within 5 days of opening of financial bid. Failure to do so will render the bid invalid.
2. A Non-blacklist Certificate, accompanied by a Rs 100 stamp and a Notary Stamp, in the bid running date /time, is mandatory for this bid. Failure to include this certificate will result in the bid being considered invalid.
3. It is mandatory to attach a written guarantee/warranty of 01 year from the date of supply of the equipment supplied along with the tender on firms' letterhead. Failure to include this certificate will result in the bid being considered invalid.
4. Bids submitted from the same IP address as the buyer or another bidder/seller are automatically rejected and not considered for further evaluation. This is to prevent collusion and ensure fair competition in the bidding process.
