If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

2. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and

its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 50% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

I. Eligibility Criteria: Only bidders qualifying on below eligibility criteria shall be considered further for evaluation of their offers:

a) The party must have successfully supplied round electromagnet (minimum 1650 diameter) to any steel plant or any organisation under PSU/Central Govt or State Govt. undertaking or any Public Limited Company in India during any one of the last five financial years till TOD.

The bidder shall submit copies of the relevant Purchase Order/Contract along with corresponding invoices as documentary evidence in support of this criteria. Bidder must submit successful trial/working certificate from the user.

Authorized dealer submitting offers on behalf of their OEM shall be considered only if their principal OEM qualifies on the above Eligibility Criteria. Relevant details of OEM along with due authorization certificate to be provided. Supplies are to be ensured from the same OEM.OEM shall be severally and jointly responsible along with the bidder for performance of the supply contract.

Note:

- a) SAIL reserves the right to verify any supporting document(s) submitted by a participating tenderer/bidder from its source(document issuing authority)
- b) In the interest of expeditious completion of verification, a participating tenderer/bidder shall provide a list of each supporting document on its letterhead as per "Annexure-S" along with the contact details (postal address, email address, landline/mobile number)of the issuing authority of each supporting document of verification
- c) Non-verification of any supporting document or information at the sole discretion of SAIL, does not absolve the tenderer/bidder of its absolute responsibility to provide only genuine document(s)in support of eligibility conditions.
- d) In case a supporting document or information is found to be fake/forged/tampered/non-genuine at any stage during tendering process and even after placement of purchase order/work order, the tenderer/bidder is liable for punitive actions as per extant guidelines of SAIL

II. Inspection terms:To be done in stages as per IPSS 1-01-001-11 at supplier's premises.After coil is placed and before filling of compound, the party should call for stage inspection. Manufacturer's Test & Guarantee certificate is to be submitted along with supply.

III. As per Preference to Make in India order, purchase preference will be applicable only for vendors having minimum 50 % local content, whereas participation in the current tender will be restricted to Class I and Class II vendors, i.e. ,vendors having minimum local content of 20%.

IV. Documents required to be uploaded with tender:

- a) Previous supply experience document and successful trial certificate, OEM authorization certificate(where applicable)

V. Risk Purchase - If the supplier fails to deliver the stores either in full or in part, within the prescribed delivery period, The Purchaser shall be entitled at his option to take alternate procurement action, at the risk & cost of the supplier for the unsupplied portion of the goods/items for which delivery has expired without cancelling the contract in respect of stores not yet due for delivery, or to cancel the contract based on progress of work , including stores not due for delivery, and, if thought fit/ necessary, to purchase the stores at the risk and cost of the supplier. The price differential in case of higher cost to SAIL.If any, shall have to be borne by the defaulting supplier. Moreover the defaulting supplier shall have no claim over the quantity, which they failed to supply.

VI. - iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
