AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### **Additional Terms and Conditions**

1. Rates being quoted by the tenderers shall be deemed to be inclusive of all kind of multiple handling, flexible hose, pipes, pumps required for filling and emptying the tankers or any other charge incidental to the requirements of the work. No claim, whatsoever, shall be admissible on account of these activities.
2. No hindrance shall be applicable/allowed for bad weather, snowfall, rainfall, hurricane, non-motorable roads, mud, slush, traffic restrictions, VIP movements, GRAP measures, Pollution restrictions etc. and alike conditions and any delay, if any, caused on account of such factors, shall have to be covered up by deploying additional labor and resources. Nothing extra shall be paid on this account over and above the quoted rates.
3. Potable water is required to be supplied from nearest NDMC filling stations (Kalibari or Jor Bagh, New Delhi or any other filling point as approved & allowed by NDMC). If NDMC, in writing, denies providing water for supply to this site, water from alternate water stations, authorized and approved by Delhi Jal Board (which then shall be approved by Engineer-in-charge) shall have to be arranged by the contractor. No claim on account of any additional distance in this case.
4. The rates are net and include all taxes or any other charge incidental to the scope of work and nothing shall be paid extra on account of this.

5. The Water Charges shall be paid by the department directly to the NDMC / Delhi Jal Board by its own. However, the agency shall submit the valid proof in the form of receipts signed from NDMC/Delhi Jal Board for verification purposes.
6. The contractor shall be liable to liaison and obtain the necessary permissions from all the authorities like NDMC / Delhi Jal Board, Delhi Traffic Police, NGT, Delhi Police and all the other authorities for the transporting water.
7. The water tanker must be in good condition with proper hygiene-devoid of rust, and with a hose pipe of desired length and diameter required for emptying the water in approx. 15-20 mins. The water tankers shall be compliant BS norms in line with GRAP measures implemented during the severe and very severe pollution days in order to ensure that water supply is not disrupted even during the extreme pollution days.
8. It is estimated that there will be a daily requirement of approx. 75kL to 80kL which shall be met by supply of water through this contract. Nevertheless, the contractor shall co-ordinate regarding the daily requirement of water with Engineer-in-charge or his authorized representative.

Notwithstanding any of the above mentioned facts, Bidders to note that the Estimate has been prepared considering 80KL of delivery of water on daily basis. However, the daily requirement may vary depending on the weather conditions, supply of water from NDMC through permanent connection and various other factors and nothing extra shall be payable for such variation in the demand to the contractor on account of loss of business, loss of profit, idle charges of machinery and resources, and the bidder shall quote his prices considering the following aspects
9. However, it is possible that there an additional demand or no demand on any given day as per requirement of the site. In case of such additional demand days or no demand days during the currency of contract, the contractor shall make his own arrangements to suit the requirements of this office and no claim on account of loss of profit, overheads, loss of business shall be accepted on account of such variation in daily demand.
10. The contractor shall submit a challan slip received from NDMC / Delhi Jal Board in triplicate for the acknowledgement along with the each trip and one copy of that slip shall be handed over at the time of offloading of water at the site. The second copy shall be attached with the running bills along with the GPS data sheets.
11. As approx. 2-3 tankers of capacity 30kL are expected to be supplied on any given day, it is imperative that tankers be fitted with pumps of sufficient capacity in order to empty one tanker in approx. 15-20mins so that the requisite demand is fulfilled as and when required.
12. However payment to the contractor shall be made on the basis of actual quantity of water supply at site in the presence of representative of Engineer-in-charge, if there is any shortfall between challan slip received from NDMC / Delhi Jal Board and actual quantity of water supply at site, recovery shall be made @ Rs. 1 per liter from contractor's bill.
13. The water's total dissolved solids (TDS) supplied shall be between 50 mg/L-150mg/L. Water with a TDS level above 150mg/L will be rejected and no payment shall be acceptable for such sub-standard water.
14. The contractor shall arrange his own TDS meter and other necessary equipment to get the water parameters verified at the site before offloading the water into the tanks.
