1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small

Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.

1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. **Generic**

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

4. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

The quantity to be procured is 12 EA ie. 12 Nos. of Carbon Monoxide (CO) gas filled cylinders. Hence the bidders are required to quote “per filled-cylinder basis”. The detailed specification is as per the specification document attached above.

I. ELIGIBILITY CRITERIA

1) Bidder should have supplied 210 cubic meter (M³) of Carbon Monoxide gas in cylinders to any Central / State Govt. Organizations/ PSUs / Joint Venture Company where at least one of the partners shall be Central or State Government Organization or PSU/ Public Limited Companies, during last seven (07) years ending last day of month previous to the one in which tender (bid) is issued.

2) PO copy/Work Order copy and proof of supply shall be submitted with offer in support of the above.

* In case any bidder has successfully supplied the material as per the above to SAIL-ROURKELA STEEL PLANT (SAIL-RSP) during the specified period, such bidders may mention the PO No, date, Qty and corresponding Invoice no, date, Qty in the technical bid. They need not submit such documents against the above clause.

** Non-submission of the documents towards fulfillment of eligibility criteria of the bid, as listed above, during bid submission, may lead to rejection of the bid.

*** Vendors who were technically suitable in GeM Bid GEM/2025/B/5787037 dtd 08-01-2025 need not submit any documents towards eligibility. However, all such bidders have to submit duly-filled and signed ANNEXURE document(s) as per bid requirement. Any new firm participating should submit all required documents in support of eligibility as per the tender criteria above.

II. SPECIAL TERMS & CONDITIONS

1. Party shall supply Carbon monoxide (CO) gas in its own cylinder.

2. Party shall supply full CO gas cylinders directly at Blast Furnace (BF) -5 laboratory. The transportation of filled cylinders to site/ Laboratory and taking back empty CO gas cylinders from the same Laboratory will be in the supplier's scope.

3. Each cylinder shall be supplied in sealed condition. Gas pressure in the cylinder shall be 130 Kg/cm² (+/-

5 Kg/cm²). This is to be certified on test certificate.

4. In case of any abnormality with respect to gas quality in any cylinder, the same shall be replaced by the party, free of cost, using his own transport, immediately.

5. Party shall submit the following during material supply:-

- Manufacturer's test certificate and hydro test certificate of the cylinders or CCOE (Chief Controller of Explosives) certificate, alongwith supply, to ensure compliance regarding quality & safety of the gas cylinders to be supplied.
- Party shall also submit Material Test Certificate mentioning the composition of gas as per the description in material text during the supply of gas.

6. Party shall supply the CO gas as per the requirement and instruction of the R&C Laboratory deptt of SAIL-RSP.

7. The party shall supply 12 (twelve) full cylinders within 30 days of contract placement.

8. Empty cylinders will be returned vide stock number: 72710001000058.

III. DELIVERY REQUIREMENT:

- The material is to be supplied within 30 days of receipt of contract by the firm,
- R&CL Department, SAIL-RSP will inform after submission of SDA at Central Store, SAIL-RSP. Supplier will be communicated either over telephone or e-mail to take the empty cylinders back from the Central Store and supply within 15 days after taking from Central Store to avoid LD charges.

IV. GUARANTEE CLAUSE: Firm to submit guarantee certificate for the supplied material as per specification alongwith declaration with respect to quality, quantity & gas pressure in each cylinder as per the specification.

V. PRICE VARIATION CLAUSE: Firm till delivery.

VI. PACKAGING CLAUSE: The valve of each full cylinder should be properly sealed to avoid any leakage. The

Quality & safety of the gas cylinders to be supplied, is the responsibility of the vendor & is to be ensured during transit and supply.

VII. INSPECTION TERM:

- The material will be done at the R&C Laboratory, SAIL-RSP.
- Inspection will be done by the department representative of R&C Laboratory after the material is received. The valve on each full cylinder should be sealed.
- Consignment will not be accepted if the valve of even any one cylinder is unsealed/ broken seal.

VIII. PAYMENT TERM: 100% against GARN within 30 days

BIDDERS TO NOTE:

1. Bidder must submit filled Annexure-A, Annexure -B (Format for undertaking by the bidder) & Annexure-S (details of supporting documents for verification), along with the offer. Formats attached in the bid document.

2. The offers of bidder(s) whose performance in SAIL-Rourkela Steel Plant (RSP) have been found to be unsatisfactory may not be considered and SAIL-RSP reserves the right to summarily reject such offers during any stage of tender, including and after price discovery.

3. In case any adverse report is received against a bidder, as an information or upon enquiry made by SAIL, in respect to capabilities and performance of the bidder, after receipt of the tender (even after opening of price bid), the quotation/ tender submitted by such bidder will be liable to be rejected on the grounds of the adverse report(s) received.

4.

i) SAIL reserves the right to verify any supporting document(s) submitted by a participating tenderer /bidder from its source (document issuing authority).

ii) In the interest of expeditious completion of verification, a participating tenderer /bidder shall pr

provide a list of each supporting document on its letter head as per "Annexure -S", along with the contract details (Postal address, e mail address, landline /Mobile number) of the issuing authority of each supporting document for verification.

iii) Non verification of any supporting document or information, at the sole discretion of SAIL, does not absolve the tenderer / bidder of its absolute responsibility to provide only genuine document(s) in support of eligibility conditions.

iv) In case a supporting document or information is found to be fake/forged /tampered/non genuine at any stage during tendering process & even after placement of purchase order /Work order, the tenderer /bidder is liable for punitive actions as per extant guidelines of SAIL.

5. Other terms

i. NO DEVIATIONS ARE ACCEPTABLE. By submitting offer against this bid, the bidder is accepting all terms & conditions of the bid as well as GeM terms & conditions.

ii. All prices quoted in GeM will be on landed cost basis, inclusive of GST and all taxes/ duties(unless otherwise specified in Special Terms of ATC).

iii. Bidders are requested to update the firm's GST registration status prior to participating in the bid. Since all prices to be quoted in GeM are on landed cost basis, inclusive of GST and all taxes/ duties, the case will be evaluated accordingly.

iv. Only relevant document(s) are to be uploaded for technical and commercial scrutiny. Submission of additional documents beyond the requirement will not be taken cognizance of. By participating in the bid, the Bidder agrees to comply with all terms and conditions without making any alterations, additions, or modifications. Any attempt by the Bidder to include additional terms or clauses in the bid document may result in the bid being rejected by the Buyer at any stage of the evaluation process. The Buyer reserves the right to take appropriate action, including but not limited to disqualification of the Bidder, cancellation of the bid and cancellation of order, at its sole discretion.

v. Bidders to compulsorily submit the duly-filled Annexures with stamp and signature of authorized representative, as part of online offer.

vi. Any technical query/ clarification, is to be routed through the pre-bid representation functionality available against this bid.

vii. Risk purchase (RPN) clause: Subject to the terms and conditions of this Agreement, if the Supplier neglects or fails to perform the Agreement by the time or times agreed upon, for any reason other than Force Majeure, the Purchaser after having come to know of such negligence or non-performance, after giving 14 to 30 days notice or any such extended period that the Supplier and Purchaser may mutually agree, to the Supplier to rectify, shall take such action as it considers fit including but not limited to taking risk purchase action for supply of the material, mitigating any losses, at the risk and cost of the Supplier as far as the undelivered quantity in that Delivery Period is concerned. The Right of the Purchaser for Risk Purchase Action is in addition to the Right of Purchaser to terminate the Contract due to the fault of the Supplier. The price differential in case of higher cost to SAIL, if any, shall have to be borne by the defaulting Supplier. Moreover, the defaulting Supplier shall have no claim over the quantity, which they failed to supply.

viii. Before dispatching the material, seller(s) must ensure the following:-

a. GeM contract is duly accepted.

b. GeM fees has been paid (if any, for contract acceptance)

c. GeM contract should remain valid till receipt of material at consignee location.

d. Invoices have been created in GeM, confirming dispatch of material

ix. SAIL-RSP will be placing back-up order against GeM contract(s) on successful bidder(s). SAIL-RSP's back-up purchase order, however, will be released only after acceptance of contract by seller in GeM. The concerned bidder has to mention the back-up order number in the invoices for proper accounting of material upon receipt in RSP.

x. Further, non-compliance of the requisites in "viii" & "ix", shall be at the risk of the vendor and any delay(s) arising out of such non-compliance, shall be on vendor's account.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
