If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. **Note to Buyer and Seller:**

The unit of measurement in this category is "Kilogram". Accordingly, buyer is required to mention its quantity in "Kilogram" only while placing the order under this category. The quantity so ordered will be supplied by the seller in pack size as mentioned in clause 5.1 of governing IS 12766 which is reproduced in table below for ready reference.

The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. #### 2. **Penalty Clause**

**Penalty of Submission of Sample:** Successful bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Sample will be provided to successful bidder and bidder must submit Artwork within 10 days for approval. Purchase order is subject to approval of sample. Delayed submission of proof of sample after ten days will attract **1% penalty** of contractual value.

**Penalty of Delayed Supply:** The supply should be made **within 15 days after our Final approval of sample**. If the supply is made after 15 days after approval but within 30 days 1% of the bill amount will be deducted as penalty. If the supply is made after 30 days after approval of sample but within 45 days 2% of the bill amount will be deducted as penalty. If the supply is made after 45 days after approval of sample but within 60 days 3% of the bill amount will be deducted as penalty. If the supply is made after 60 days after approval of sample without any genuine reasons the suitable action of Blacklisting /Delisting will be taken. In case of part deliveries, penalty will be imposed on part contract value as per above limits.
