(l) ALL DOCS UPLOADED BY BIDDER MUST BE DULY SIGNED BY BIDDER WITH SEAL OF THE FIRM.

(m) THIS ATC SHEET MUST BE ALSO UPLOADED, DULY SIGNED BY BIDDER WITH SEAL OF FIRM.

(n) SAMPLE MUST BE APPROVED BEFORE BULK SUPPLY.

(o) TEST CERTIFICATE BEARING WITH MFG DATE AND EXPIRY DATE MUST WITH BULK SUPPLY.

(p) OEM PROVIDER ADDRESS, CONTRACT NUMBER, E-MAIL ID, SHOULD BE PROVIDED FOR VERIFICATION.
