If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

DETAILED TECHNICAL SPECIFICATION FOR SCHEDULE ITEMS

Schedule item No. 1 - Hiring of one Non-AC passenger vehicle SUV (Ertiga / Mahindra Bolero Neo / Scorpio or similar type) in good working conditions for ADEE/TRD/AML for a period of Two Years (Approximate 2000 KMS running per month) with contractor's vehicle, driver, cleaner, fuel, oil, lubricants, accessories, major & minor repairing, expenses, permit, repair and maintenance, taxes etc.

The price shall cover providing of four wheeler vehicle having valid license, in good working condition along with contractor's driver, providing fuel and maintenance complete in all respect on demand, for use of transporting of ADEE/TRD/AML to supervision of the work etc, and minimum payment of guaranteed distance of 2000 KMs. per month.

The vehicle should be SUV (Ertiga / Mahindra Bolero Neo / Scorpio or similar type) model in good working conditions. The vehicle should be available to the Railway with driver, fuel, Engine oil, etc. around the clock on all days of a week irrespective of holidays. If required Railway may also utilize the vehicle beyond these hours, which will be indicated a day in advance. Contractor should give the Mobile Nos and residential addresses of the drivers nominated by him and shall ensure that driver can be called at any time round the clock on any day. The driver should be provided a mobile phone with incoming and outgoing call facility

2. Rate of charges for each extra KM beyond 2000 km per month:-

Rates to be paid for each Kms beyond 2000 Kms of distance cover by vehicle for month distances

as per Gems Service Level Agreement (SLA) available on GEM portal. (Extra per km charges=Monthly package cost divided by no. of kms in monthly package multiplied by factor 0.5)

3. Rate for each additional hours beyond 320 hrs per month:-

Rates to be paid for each Kms beyond 320 hrs per month cover by vehicle for month hours as per Gems Service Level Agreement (SLA) available on GEM portal. (Extra hour charges = Monthly package cost divided by no. of hours in monthly package multiplied by factor 0.4.)

5. PAYMENTS AND RECOVERIES:

No advance payment shall be made to the contractor. The payment terms shall be governed as under. Progress payments will be made on monthly basis.

Subject to any deductions or recoveries, which the purchaser be entitled to make under the Contract, the contractor shall unless otherwise agreed to be entitled to get the following payments subject to conditions stipulated in subsequent paragraphs.

- Progress payments
- Final settlement.

PAYMENT TERMS & SUBMISSION OF CONTRACTOR'S BILL :-Unless otherwise agreed upon between the parties, payment of work will be made on submission of bill in the prescribed Railway Forms, which may be obtained from the GEM portal in accordance with the instructions given in the letter of acceptance.

- Payment for hire charges will be made monthly after due verification of logbook and necessary certification by the officer in charge.
- ON ACCOUNT PAYMENT: - 100 % ON ACCOUNT** payment shall be arranged to the contractor on monthly basis for any of the schedule items those completed by the contractor. **The 100% minimum payment for guaranteed distance of 2000 Kms per month will be made.**
- FINAL PAYMENT:** - Final payment shall be arranged to the contractor after satisfactory completion of entire work as per schedule items.

The above payment will be made to the contractor on submission of the bill accompanied by required documents in accordance with the procedure of contract, such as verification of power of attorney from Legal department of Railway, bank guarantee for security deposit, Log book of vehicle and contractors GST invoice/challans, inspection certificate granted by the Engineers, certificate of completion of work etc. All the payments shall be subject to recoveries which may be due, if any.

6. The toll taxes and parking payment will be paid by the Railway Authorities through bills of contractor on producing toll tax paid receipt duly certified by contractor and user of vehicle.

7. The vehicle should not be more than 3 years old (In terms of manufacturing) as on the date of tender opening but also should be in good fettle, mechanically sound and decent maintained with neat & clean seat cover etc.

8. The vehicle deployed shall be parked at the user's premises after the duty hours & cannot be taken out without written permission from the user.

9. The firm must submit the registration papers of bid vehicle with their firm of lease documents along with bid.

10. Performance Guarantee

The procedure for obtaining Performance Guarantee is outlined below:

The successful bidder shall have to submit a Performance Guarantee (PG) within 15 (Fifteen) days from the date of issue of Letter of Acceptance (LOA). Extension of time for submission of PG beyond 15 (Fifteen) days and upto 60 days from the date of issue of LOA may be given by the Authority who is competent to sign the contract agreement. However, a penal interest of 12% per annum shall be charged for the delay beyond 15(Fifteen) days, i.e. from 16th day after the date of issue of LOA. Further, if the 60th day happens to be a declared holiday in the concerned office of the Railway, submission of PG can be accepted on the next working day.

In all other cases, if the Contractor fails to submit the requisite PG even after 60 days from the date of issue of LOA, the contract is liable to be terminated. In case contract is terminated railway shall be entitled to forfeit Bid Security and other dues payable to the contractor against that particular contract, subject to maximum of PG amount. The failed Contractor shall be debarred from participating in re-tender for that work. Decision of Authority competent to sign the Contract Agreement would be final in case of any dispute

11. The hired vehicle is required for ADEE/TRD/AML A under Nagpur Division for period of two years.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
