4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 3. Buyer Added Bid Specific ATC

### Important Instructions to Bidders

#### 1. Precedence of Documents

Bidders shall carefully read the attached **GAIL Tender Document** in its entirety before submitting the bid. In case of any ambiguity, inconsistency, or contradiction between the provisions of the GAIL Tender Document, GeM Bid Document, GeM General Terms & Conditions (GTC), GAIL General Conditions of Contract (GCC), or any other associated document, **the provisions of the GAIL Tender Document shall prevail and be binding.**

#### 2. Submission of Mandatory Forms and Formats

All **Forms, Formats, Declarations, and Annexures** prescribed in the tender document shall be **properly filled, duly signed, and stamped** by the authorized signatory and submitted along with the bid. Non-submission or incomplete submission of any mandatory document may lead to rejection of the bid.

#### 3. Bid Evaluation Criteria (BEC)

Bidders shall strictly refer to **Section-II of the GAIL Tender Document** for the **Bid Evaluation Criteria (BEC)** and submit supporting documents strictly in accordance with the requirements specified therein. The BEC provisions mentioned in Section-II shall **supersede any other provisions** relating to eligibility or evaluation mentioned elsewhere in the bid documents.

#### 4. Contractual Precedence After Award:

After award of contract, in case of any variation or inconsistency between the **GeM Contract** and the **SAP Purchase Order (PO) / Letter of Award (LOA)** issued by GAIL, the **terms and conditions of the SAP PO / LOA shall prevail.**

#### 5. Tender Schedules and Eligibility: The tender consists of the following schedules.

- **Schedule-1: CGD Bhubaneswar**
- **Schedule-2: CGD Cuttack**

**In Each schedule of the tender three (03) types of vehicle services are required:**

- i. **Type-1 (MUV)** - “Quick Response Team Vehicle (Pickup Vans like Mahendra Bolero Tata Pickup or similar with 5 - Seater & Tool Carrying Space)
- ii. **Type-2 (SEDAN)** - “Central Control Room Vehicle (Maruti Dezire or EECO or Honda Amaze or Equivalent).”
- iii. **Type-3 (SEDAN)** - “General Shift (Vehicle Maruti Dezire or Honda Amaze or Equivalent)”

A bidder may quote for **either one or both schedules**, provided the bidder independently or on cumulative basis meets the **BEC requirements** for the respective schedule(s).

#### 6. **Schedule of Rates (SOR) and Price Quotation**

Bidders are advised to carefully read and strictly follow the instructions provided in the **Schedule of Rates (SOR)** for the respective schedule(s).

- o Unit rates shall be quoted in the SOR.
- o The **lump sum price** derived from the SOR shall be quoted in the **‘GeM Offered Price’** field on the GeM portal.
- o The quoted **‘GeM Offered Price’** shall exactly match the total amount arrived from the SOR.

#### 7. **Upload of SOR with Price Bid**

The **duly filled, signed, and stamped SOR** shall be mandatorily uploaded along with the price bid under **“Financial Documents Indicating Break-up of Price”**.

#### 8. **Tender Document Availability**

The complete tender document has been uploaded under **Buyer Added Additional Terms and Conditions (ATC)** on the GeM portal. Bidders are advised to download, review, and understand all provisions before submission of their bids.

### अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
