2. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

(1) Bidders are requested to attach followings self declaration certificates at the time of submission of bid with mentioning date that : -(i) I/We am/are not under liquidation, court receivership or similar proceedings and also not declared bankrupt by any agency. (ii) The bidder should not have been blacklisted or debarred by any Central/State Government/Agency or Central/State Government public sector/undertaking.

(2) The bidder must submit the undertaking that no work of the bidder has been terminated on account of poor performance in past three year from the date of opening of bid.

(3) Similar Nature of Services is defined as " Any independent work involving Cab & Taxi (Hatchback, Sedan, Premium, Sedan, SUV, MUV, Premium SUV/MUV, Luxury Sedan, Luxury SUV/MUV) hiring services on monthly/daily/per Km basis."

(4) Duration of the Service Contract may be extended upto 06 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).

(5) Office of the bidder/service provider is mandatorily required to be located in the state of the consignee (i.e. User) for the sake of better co-ordination, smooth service and other administrative factors. Documentary evidence to be submitted as required in terms of Clause No.7 of the Bid STC, must be issued by Central/State/Local government bodies, or must be a valid legal document which suggests that firm's office is present in the state of the consignee. Otherwise, offer is liable to be rejected.

(6) For financial turnover & experience criteria "F.Y." period is considered and in current year it should be calculated up to the bid opening date".

(7) Bidder must submitted documents with showing that at least 30% of bid quantity (i.e. One (01) No. MUV) or higher version commercially registered vehicles should/must be registered with service provider's name or in the name of the proprietor/partner of the service provider. The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
