1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. Special terms and conditions-Version:2 effective from 10-11-2025 for category Hopper Tipper Dumper for Garbage

1. **Special Terms and Conditions for Hopper Tipper Dumper for Garbage**

1. This category is created to cater to the requirement of buyer for procurement of Hopper Tipper for garbage collection. This category is a **BID-ONLY Category**, and procurement will occur exclusively through the bidding process.

2. The detailed specifications for the fabricated tipper container is to be defined by the buyer in the bid. These may include the following parameters :

1. Dimensions of garbage tipper container
2. Grade of material to be used for tipper construction
3. Payload Capacity defined in the category is the total of weight of container body and weight of material to be carried. Buyer may like to define minimum container weight required as per the selected tipper container capacity/volume (cubic meters). Additionally, Buyers may estimate the weight of the material based on the density of the waste intended to be collected. Based on these two inputs- container weight and weight of material to be carried, payload capacity may be selected while creating the bid.
4. Minimum gross vehicle weight of chassis to be allowed for the required tipper.

3. Buyer may seek Chassis / Original Vehicle Manufacturer's authorization from Body Builders in the bid.

1. **Generic**

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1. The Bidder (OEM or Authorized reseller of OEM) intended to supply under this tender, must have supplied garbage tipper/ hopper tipper dumper to any PSU/govt organization/ Semi Govt Organization/ULB's within the last three years for the date of NIT. The Bidder/OEM must attach valid work order with work done certificate as proof of experience. The private order will not be considered.

2. OEM in his name should have in the last Three years i.e., 2022-23 to 2024-25, achieved in at least two financial years' minimum annual financial turnover of Rs.450.00 lakhs. Certified balance sheet and sales Turnover certificate issued by a Chartered accountant (should have UDIN number). The OEM should produce Net worth and Liquidity Asset Certificate with UDIN.

3. Authorized Reseller his name should have in the last Three years i.e., 2022-23 to 2024 25, achieved in at least two financial years' minimum annual financial turnover of Rs.100.00 lakhs.

4. Pan card and GST certificate must attach with documents.

5. The OEM should have ISO 9001 certification. The Manufacturer should be certified with IAF and should attach the active certificate along with the Bid.

6. Self-declaration Affidavit stating that the firm is not Blacklisted declaration on Rs. 100.00 stamp paper

7. The requisite EMD shall be paid as specified in bid. Exemption from payment of EMD will be allowed to the bidders registered with NSIC/DIC only. Bidder who has not paid EMD amount as specified will be disqualified

8. If demanded by the purchaser, The Bidders should produce Original Documents (Submitted during the Tender) for Physical Verification within 10 days from the date Technical Bid Opening.

9. The OEM must have registration with NSIC/DIC. The OEM have to attach valid registration certificate along with bid documents.

10. Goods should be delivered on site delivery basis with unloading.

11. Rates should be inclusive of all taxes, transportation, loading & unloading.

12. GST Clearance certificate up to January, 2026. (GSTR 3B)

13. All Bidders must produce drawing and layout of the machine prior to bid submission physically before 5 days of end date and will have to take approval on it. Bidder must have to upload approved drawing copy along with bid document.

14. The OEM/Bidder should provide undertaking for availability of spares parts and consumable for the tendered machinery for minimum 5 years.

15. The Bidder/OEM must produce ISO 14001, 45001, WPQ and PQR certificate along with bid documents..

16. Bidder/OEM or Authorized reseller of OEM through its authorized service center/ Workshop within 50 km Radius and shall provide the required maintenance services as required. The Bidder/OEM shall submit authorized service center certificate.

17. The bidder who failed to upload any single document will be disqualified. The purchaser reserve all right to accept or reject any or all bidders.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
