If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM\\_No.1\\_4\\_2021\\_PPD\\_dated\\_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

**Buyer Added Bid Specific Terms and Conditions:**

**1. Experience:** Firm must have experience in maintenance/erection/commissioning of Mechanical /Hydraulic presses or Furnaces or Machining centers 30% of the estimated cost (i.e. Rs. 10.58 lakhs)within last three years from the date of bid opening in Govt./PSU/Public Sector Company. In this regard firm has to submit the scanned copy of at least one supply order along with job completion certificate If required capacity verification based on documents furnished by the firm in the technical bid may be undertaken if considered necessary by the competent authority at MSF. Firm will clearly mentioned proper address, contract No., contract person, mail Id where executed the work.

It is mandatory for all bidders to submit the past experience certificate, there will be no exemption/relaxation on MSE and start ups

**2.Payment Terms :** Payment shall be made on each completed quartely basis from the start of actual work against the satisfactory job completion certificate issued by Eic & SIC . At any time during the contract, if performance of the contractor is found unsatisfactory, the contract will be terminated without any advance intimation.

**3. EMD :**2%(Rs.70,595.00) of the estimated cost however exemption is applicable in submission of Micro & Small Enterprises having Udyam Registration Certificate Number issued by department of Micro, Small & Medium Enterprises (MSME) or firms regd. with Ordnance Factories/the Central Purchase Organization /the concerned ministry / Department / startup as recognized by Dept. of Industrial Policy & Promotion (DIPP ) or Central PSUs\_

**4. Security Deposit:** After placement of Supply Order firm will submit Security Deposit 5% of the Supply Order value in the form of Bank Guarantee/Term Deposit. Which will be valid upto two months beyond the work contract period.

**4. Payment Terms: As mentioned Scope of Work Sl. No.10**

**5 Penalty:** As mentioned Scope of work SI. No. 9

**6.** Buyer Added Terms and Condition i.e. ATC will supersede the clauses of GEM GTC.

**7.** Firm will submit acceptance of Scope of Work and Terms and Condition of the bid in company's letter head with stamped and signature.

**8. Local Office:** Firm should have its local office in the district of North 24 Parganas/South 24 Parganas/Kolkata/Howrah/Hooghly and Nadia district of West Bengal. For this purpose a registration certificate under West Bengal Shop & Establishment Act or GST registration certificate shall be treated as valid document.

**9. Manpower:** As mentioned Scope of Work SI. No. 7

**10.Option Clause:** The work completion period will be one year from the date of starting of work. if requirement is exist it may be extend up to three(03) months i.e 25% of the Supply Order value with same rate and same terms and condition of the Supply Order.

**11. Safety & Security:** The persons engaged by the contractor will observe norms of safety and security laid down respective safety and security office MSF. The contractor shall arrange for PVR in respect of his workmen apart from injury/accidents during the contract period. In this regard firm shall have full responsibility for their workmen and MSF shall have no any responsibility

**12. Liability:** The contractor shall indemnify and keep indemnified MSF, Ishapore against losses, cost of injuries and all liability arising out of or in consequence of the execution of the contract.

**13. Working Hours :** As mentioned scope of work SI. No. 6

**14. Man power: As mentioned scope of work SI. No.7**

**5. Duration of Contract:** period of this contract is for one year from the date of commencement of work. The work should be commencing withing ten(10) days form the date of placement of supply order.

**16.** The firm has to provide all tools and tackles for the exeution of work.

**17.** The purchaser will not take any responsibility whatsoever, in the event of any accident met by contractor's men while on their duty. The contractor should submit the proper workmen compensation policy (insurance) at the time of requesting for entry permission.

**18.** Firm will submit workman insurance certificate for all the workers engaged in the job.

**17. OPTIONAL SITE VISIT:**

The Bidder is advised to visit and examine to obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder.

The Bidder representative shall be allowed entry upon consignee premises for such visits. Only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding. Working condition weather etc. On its own before.

### **18. Safety:**

Firm's offer will be inclusive of all safety equipment. MSF will not provide any safety equipment.

### **19. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates/documents sought in the Bid document. ATC and Corrigendum if any.

### **20. Buyer Added Bid Specific ATC**

Bidder shall carefully read the clauses mentioned in ATC & shall attach the compliance of the same duly signed and stamped. Mandate form to be submitted in prescribed format.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
