the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

9. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 7 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. 1. The authorized bidder must submit their bid on behalf of the firm /Company /Manufacturer/OEM along with bid specific authorization issued by the OEM to the bidder failing which offer will be summarily rejected. The authorization letter must contain contact details and email Id of the firm/company/OEM. Valid authorized dealership certificate to be submitted by the re-sellers with the offer.

2. The OEM/Bidder must submit the following certificates (to be uploaded with this bid)

- ISO 9001: The participating OEM/bidder of the offered products must have ISO 14001:2015, ISO 45001:2018, ISO 9001:2015, ISO 21015:2007, ISO CE50001:2018, ISO 130485:2016, ISO 27001:2013 certifications.

- The participating OEM/bidder is required to upload, along with the bid, all relevant Certificates, such as Green Pro, Green Guard, AIOTA, BIFMA, SEFA, SEDEX, GMP, CE, IGBC and product-wise test report certificates. The test report certificates should be provided for each furniture products as specified in the bid document. 4. Proven-ness Criteria - The goods shall be considered proven provided the tendered / similar item(s) of same/ similar (definition of similar will be specified in individual NITs) / higher specifications / ratings / versions, etc. have been supplied during the last 5 years from the date of tender opening against orders of CIL and its subsidiaries, other PSUs, Government Departments and Private Organizations, and their performance has been found satisfactory. These Purchase Orders must be supported with suitable documents proving that the supply has been completed and accepted by the Consignee such as Inspection release note/CRAC/ Bank statement as proof of payment/TDS certificate.

1.
