1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. Buyer Added text based ATC clauses

- 1) The Supplier shall supply one Chiller and one Vacuum Pump of **Make: Rivotek, Model: 7004 4000**, including all standard accessories, manuals, and documents, in accordance with the manufacturer's specifications and the Purchase Order.
- 2) The prices quoted shall be firm and as agreed in the Purchase Order. All applicable taxes, including GST and statutory duties, shall be charged as per prevailing government regulations. Payment shall be made strictly as per the payment terms mentioned in the Purchase Order.
- 3)The Supplier shall ensure delivery of the chiller and vacuum pump to the Buyer's site within the agreed delivery period from the date of the Purchase Order. The equipment shall be properly packed to avoid transit damage, and transit insurance shall remain the responsibility of the Supplier until delivery at site.
- 4) The Buyer shall have the right to inspect and test the equipment upon delivery and commissioning. Acceptance shall be subject to the equipment meeting the agreed technical specifications and satisfactory performance. Any defects or non-conformities observed shall be rectified or replaced by the Supplier at no additional cost.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and

resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
