1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in

India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

**1. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

**2. Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

**3. Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

**4. Service & Support**

The Service Provider is required to have at least 40 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

**5. Service & Support**

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

**6. Forms of EMD and PBG**

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C

. The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

## 7. Forms of EMD and PBG

## 8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

### 1. Compliance with Minimum Wages:

The bidder must ensure that all staff engaged in the execution of this contract are paid wages in compliance with the applicable minimum wage laws and statutory provisions of the Government of India and the State of Jharkhand.

### 2. Geographical Presence:

The bidder must have an operational office or geographical presence within the State of Jharkhand. Proof of such presence must be submitted with the bid documents.

### 3. Timely Payment of Wages:

The bidder shall ensure regular and timely payment of wages to all engaged staff on a monthly basis, at the agreed-upon rates established at the time of appointment.

The bidder must submit proof of wage payments ( Transaction No./ Payment Certificate) to this office prior to the processing of each billing cycle.

Non-compliance with this condition will attract penalties as follows:

a) First Instance: If the condition is not fulfilled before a billing cycle, 10% of the bill amount will be deducted as a penalty. If compliance is met in the subsequent billing cycle, 8% of the 10% penalty will be refunded to the bidder, and the remaining 2% will be retained as a penalty.

b) Second Instance: If non-compliance persists in the second billing cycle, an additional 10% penalty will be imposed, if compliance is met in the subsequent billing cycle, 60% of the total penalty collected up to that point will be refunded to the bidder, while the remaining 40% will be retained.

c) Third Instance: If non-compliance persists in the third billing cycle, again an additional 10% penalty will be imposed. If compliance is met in the fourth billing cycle, 60% of the total penalty collected up to that point will be refunded to the bidder, while the remaining 40% will be retained.

d) Fourth Instance: Continued non-compliance beyond the third billing cycle will result in termination of the contract without further notice.

## Service Compliance and Penalties

The bidder is required to ensure proper security, maintenance, hygiene, cleanliness, and upkeep of office and ORH. Additionally, proper cooking and serving arrangements must be maintained at ORH. The satisfactory completion of these services must be certified by the Engineer-in-Charge. The bidder shall submit proof of satisfactory service to this office before processing each billing cycle.

Failure to comply with these conditions will result in penalties as detailed below:

a) First Instance: If the conditions are not fulfilled before the first billing cycle, a penalty of 1% of the bill amount will be deducted.

b) Second Instance: In the event of non-compliance in the second billing cycle, an additional penalty of 2% of the bill amount will be imposed.

c) Third Instance: For continued non-compliance in the third billing cycle, an additional penalty of 3% of the bill amount will be imposed.

d) Fourth Instance and Beyond: If non-compliance persists beyond the third billing cycle, the contract will be terminated without further notice. The above penalties are in addition to any other remedies available under the terms of the contract or applicable law

1. Mandatory Certification:

The bidder must provide a written certification along with supporting proof that the condition related to geographical presence (Condition 2) has been fulfilled at the time of bid submission.

The bidder must also certify their commitment to fulfilling the requirements regarding minimum wages (Condition 1) and timely payment of wages (Condition 3) during the contract period.

2. Contractual Obligations:

These conditions are mandatory, and failure to comply with any of them will be considered a breach of contract, subject to penalties, withholding of payments, or termination of the contract as detailed above

- A. This is the minimum manpower requirement. However contractor shall have to deploy adequate work force to cope up with the work load as detailed in schedule of service and as and when required. Contractor will be responsible for weekly rest, roster hours, provision of leave and other establishment benefit to the staff deployed by him etc. However the requirement as per schedule given above shall have to be fulfilled.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1

bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
