**1. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

**SCOPE OF WORK AND TERMS & CONDITIONS**

**Scope of Work:**

1. The work shall be executed under the BOP scope at 3 × 660 MW, NUPPL, Ghatampur (Uttar Pradesh ). Payment for this package shall be directly released by NUPPL.
2. The scope includes deployment of skilled manpower and packing of 400 kV GIS materials, along with supply of packing materials, by M/s Hyosung T&D India Private Limited at the NUPPL site.
3. All packing activities shall be carried out under the direct supervision and sole responsibility of M/s Hyosung T&D India Private Limited.
4. Supply of all required packing materials for complete packing of 400 kV GIS materials, as per the 400 KV GIS materials list for shifting to the Hyosung factory, shall be in the scope of M/s Hyosung T&D India Private Limited. Transportation of packing materials from the vendor's location to the site shall also be borne by M/s Hyosung.
5. M/s Hyosung shall deploy adequate skilled manpower required for packing activities till completion of the work. Travel expenses of such manpower shall be borne by M/s Hyosung.
6. Accommodation for deployed manpower shall be arranged at the NUPPL Guest House on chargeable basis. Vehicle arrangements for pick-up and drop between the guest house and NUPPL site shall be provided by NUPPL.
7. Labour support, as required during the packing activities, shall be provided by NUPPL.
8. HR statutory compliance shall not be applicable for this package.
9. All lifting equipment such as Hydra, crane, suitable lifting belts, and guide ropes shall be arranged by NUPPL. However, any specialized tools specifically required for execution of the job shall be arranged by M/s Hyosung.
10. M/s Hyosung's manpower shall strictly adhere to all safety procedures and NUPPL safety regulations . In the event of any accident, fatal or otherwise, occurring during execution of the work, M/s Hyosung T&D India Private Limited shall fully indemnify NUPPL against all risks, claims, litigations, and financial liabilities arising therefrom.

**Terms of Payment:**

1. 100% payment shall be released against submission of a certified bill within 15 days from the date of completion of work.
  - No advance payment shall be made.
2. The following documents shall be submitted along with the RA Bill:
  - Original Bill and Tax Invoice, duly signed by the authorized representative of M/s Hyosung
  - Work Execution Report for processing of the bill
  - All applicable statutory compliance documents, if any

**Mode of Payment:**

- Interest on delayed payments shall not be admissible under any circumstances, and any interest claims mentioned in the supplier's invoice shall not be entertained.

**Other Conditions:**

1. The Bidder shall declare that their company is not banned/debarred/blacklisted by other Central Public Sector Enterprises (CPSEs)/Government Entities as on the original scheduled date of Bid opening. In case while processing the Bid or during post award of Bid, any such banned/Debarred/Blacklisted instances by other Central Public Sector Enterprises (CPSEs)/Government Entities, is known to NLCIL/NUPPL then the bidder will be disqualified for that particular Bid, if the Bid is under process. If already awarded, then the Purchase Order/Contract will be terminated. In the above circumstances, Bidder shall not have any claim on NLCIL/NUPPL towards such disqualification or termination of Contract/Purchase Order. The Bidders shall submit the declaration as per the format attached.

2. **Bidders must upload a certificate as per format attached in Buyer Added Bid Specific ATC from the bidder regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected.**

3. **Preference to Make in India:** MII Purchase Preference is applicable as per O/o No. P-45021/2/2017-PP (B E-II) - Part (4) Vol. II Dated: 19th July, 2024 issued by Ministry of Commerce and Industry, DPIIT, Government of India.

**Verification of Local Content:** The bidder shall give self-certification for local content in the quoted item (goods/works/services) at the time of tendering. However, at the time of execution of the project, for all Contracts above INR 10 Crore, the contractor/supplier shall be required to give local content certification duly certified by cost/chartered accountant in practice. For cases where it is not possible to provide certification by Cost/Chartered Accountant at the time of execution of project, the supplier shall be permitted to provide the certificate for local content from Cost/Chartered Accountant after completion of the contract, within time limit acceptable to the procuring entity. In case the Contractor/supplier does not meet the stipulated local content requirement and the category of the supplier changes from Class-I to Class-II/ Non-local or from Class-II to Non-local, a penalty up to 10% of the contract value may be imposed. However, contract once awarded shall not be terminated on this account.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
