<b>For Buyers:</b>		
1.	Product Verification	A unique device serial number shall be provided by the seller at the time of supply, which is mentioned on the product. The buyer/consignee shall be able to verify the complete product details, including configuration, through the OEM website. The buyer/consignee should be able to perform these verifications without needing to create an account on the OEM website.

2. Operating System

- a. There is no requirement that the OEM of the All in One PC should be a device partner of Microsoft or hold a valid authorisation from Microsoft
- b. Microsoft OS may be sourced directly from Microsoft by OEMs holding device partner status, and those not holding device partner status may source from authorized distributors, i.e., Ingram/Reddington and their authorized channel partners.
- c. Buyers may ensure that the authorisation from Microsoft shall not be made a mandatory requirement in bids.
- d. If supplies are made as per brands of OEMs who are global device partners, then the serial number of the machine supplied can be used to check the details of the product from the website of the OEM.
- e. In the case of local device partners of Microsoft, OS details such as the digital key number should be produced with supplies, and the buyer may verify them from Microsoft.

**OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## 2. **Purchase Preference (State)**

**Bid reserved for MSE from the State of Bid Inviting Authority:** Procurement under this bid is reserved for purchase from Micro and Small Enterprises from the State of Bid Inviting Authority having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. ## 4. **Buyer Added Bid Specific ATC**

1. The Bidder shall be a legally registered entity in India and shall have been in operation for atleast three years as on last date of bid submission. Certificates of incorporation or GST Registration Certificates along with relevant legal document
2. The Bidder must have average annual turnover of Rs 50 lakhs or above in last three financial years. The copies of Audited Annual Accounts/Statutory CA Certificate for last three years shall be uploaded along with the bid.
3. The bidder should be authorized by its OEM of products mentioned in the bid documents. Bid specific MAF should be submitted by bidder.
4. The bidder must have one office in Madhya Pradesh. Please upload the copy of any two of the following: Property tax bill/Electricity Bill/Telephone Bill/VAT/GST Registration/ Lease agreement.
5. The bidder must submit an undertaking that they have not been black listed/ debarred by any state government / central government / PSU in last three years as on last date of bid submission. Undertaking on the 500rs. Stamp paper duly Notarized in favor of department that the firm has never been blacklisted/ barred (temporary or permanent) and disqualified by any state government / central government / PSU undertaking in India needs to be furnished.
6. No Deviation Certificate: Bidder should submit the undertaking of No deviation for the Technical Specifications ask in bid.
7. The Bidder must submit their valid PAN, GST Registration Certificate.

8. The bidder should submit their ISO 9001:2015.
9. The bidder's quoted rate of all items must be inclusive of all taxes and charges, No any other charge will be payable.
10. EMD Submission is mandatory for every bidder and Hard copy of the EMD must be submitted in the department before bid end date. Acknowledgement must be uploaded along with technical bid.
11. Bid is reserve for Bidders having Madhya Pradesh GST Certificate Only.
12. Delivery period for the products is strictly 15 days irrespective of what mentioned in bid document. If bidder fails to deliver the material in 15 days, order may be cancelled and Department is not liable to provide any clarification regarding the same. And EMD will be forfeited by Department. Bidder has to provide an affidavit on 500rs. stamp duly notarized regarding the same so that in future if order is cancelled due to non delivery of material in stipulated time, bidder cannot claim any legal procedures against the buyer Department.
13. MSME exemption is only for manufacturers. If the bidder seeks exemption in experience and turnover, it is mandatory to provide documents supporting manufacturing units, a GEM vendor assessment report, and an NSIC certificate, along with other bid documents for all the products. Firm splitting is not allowed.
14. For Experience criteria bidder or its OEM must have experience of 3 years for supply of same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year.
15. It is mandatory to submit sample of the product in the department before bid end date.

1. The Bidder shall quote All in One computers of Top 5 IDC brand only. They should submit the related documents to prove that the brand is included in Top 5 IDC brands. Any brand other than top 5 IDC certification will not be considered and bid will be rejected.

3. Bidder should quote Products from those OEM, who has total Indian average annual turnover of Rs. 100 Cr. or above in last three financial years. The copies of Audited Annual Accounts/Statutory CA Certificate for last three years shall be uploaded along with bid.
4. IT equipment shall be IPv6 ready from day one.
5. OEM of Products should have working Service support mechanism in same state to support the services under warranty period. Service setup details on OEM letter head/ OEM Undertaking should be submitted by bidder in technical bid
